**Warrant for Annual Town Meeting, March 2, 1896 – File 12 Warrant
No. 7**

Essex SS: -

To Amos G. Jones, one of the Constables of the Town of Methuen
in said County,

Greeting: -

In the name of the Commonwealth of Massachusetts you are hereby
required to notify the inhabitants of the Town of Methuen qualified to vote in
elections and Town affairs to meet at the Town Hall in said Town on Monday the
second day of March next at eight o'clock in the forenoon, then and there to act
on the following articles, viz: -

- Article 1 To choose a Moderator to preside at said meeting
- Article 2 To choose a Town Clerk, Treasurer, Collector of Taxes, Selectmen,
Assessors, Overseers of the Poor, one School Committee to serve three
years in place of William M. Rogers and Geo. B. Bradley, one Water
Commissioner to serve three years in place of Daniel W. Tenney, one
Trustee of Nevins Memorial to serve two years in place of Joseph S.
Howe, Constables Auditor of Accounts, Fence Viewers, “Yes” or “No” in
answer to the question “Shall License be granted for the sale of
intoxicating liquors in this Town?”, also to choose all other necessary
Town officers in such manner as the Town may determine. The polls may
be closed at one o'clock p.m.
- Article 3 To hear the Annual Report of the Selectmen and act thereon.
- Article 4 To raise such sums of money as may be necessary to defray Town charges
for the ensuing year and make appropriations for the same.
- Article 5 To determine the manner of collecting taxes the ensuing year and act
thereon as the Town may think proper.
- Article 6 To see if the Town will authorize the Town Treasurer with the approval of
the Selectmen to hire money in anticipation of taxes of the current
municipal year and
to issue notes of the Town therefor.
- Article 7 To see if the Town will vote to approve and accept the list of Jurors
prepared by the Selectmen for the ensuing year.
- Article 8 To hear the report of committees and act thereon.

- Article 9 To determine what compensation the Town will grant the members of the Fire Department for their services the ensuing year.
- Article 10 To determine the manner of appropriating the amount received from dog taxes, in accordance with Chapter 102 Section 107 of the public statutes.
- Article 11 By request of Wm. B. Greene Post 100 G.A.R. to see if the Town will vote to appropriate one hundred and fifty dollars for the purpose of decorating the graves of our soldiers and sailors on Memorial Day, May 30th 1896, said money to be expended under the direction of the above post.
- Article 12 By request of Lorin O. Norris and others, to see if the Town will vote to employ four night watchmen for protection of the village business district and Arlington section and appropriate twenty five hundred dollars for the same.
- Article 13 By request of George W. Towne and others to see if the Town will vote to Macadamize Chase Street from Broadway to the Arlington Mills and appropriate fifteen hundred dollars for the same.
- Article 14 By request of Lorin O. Norris and others, to see if the Town will vote to purchase about 370 feet of edgestone to be used on Park and Lawrence Streets near the Baptist Church and appropriate one hundred and ninety dollars for the same.
- Article 15 By request of John McGuire and others, to see if the Town will vote to build a sidewalk on the left hand side of Mystic Street from the residence of Mrs. Connor to the driveway of Mr. Webb and appropriate one hundred and fifty dollars for the same.
- Article 16 By request of William Waterworth and others, to see if the Town will vote to Macadamize Centre Street from Broadway to the Lawrence line, and appropriate two thousand dollars for the same.
- Article 17 By request of Michael Dwyer and others to see if the Town will vote to widen and grade Cross Street from Pelham Street to the pumping station and appropriate one thousand dollars for the same.
- Article 18 By request of John T. Mannifield and others to see if the Town will vote to instruct the Water Commissioners, to take the register of water semi-annually instead of quarterly as heretofore the same to be taken in July and December.

- Article 19 By request of Elias Grimes, to see if the Town will vote to Macadamize a portion of Prospect Street beginning near the house of Mary Mitchell and appropriate five hundred dollars for the same.
- Article 20 By request of John T. Mannifield and others to see if the Town will instruct the Street Commissioner to remove ashes from private dwellings in the Town and appropriate two hundred and fifty dollars for the same.
- Article 21 By request of Maurice Flahive to see if the Town will vote to instruct the Selectmen to prevent all persons from dumping rubbish on the highway at the public dump and have the road commissioner keep it in a clean and healthy condition.
- Article 22 By request of Joseph E. Buswell to see if the Town will furnish one thousand feet of hose, five hundred feet to be located in the vicinity of “Marston Corner”, and five hundred fee in the vicinity of the residence of Joseph E. Buswell and appropriate five hundred dollars for the same if necessary.
- Article 23 By request of Joseph E. Buswell to see if the Town will vote to appropriate one hundred dollars for continuation of sidewalks on Prospect Street.
- Article 24 By request of John Austin, to see if the Town will vote to maintain an arc light on Pleasant Street near Highland Street and appropriate seventy dollars for the same.
- Article 25 By request of Fred E. Lorenz and others, to see if the Town will vote to maintain three electric lights in the Currier School District, and appropriate one hundred and twenty five dollars for the same.
- Article 26 By request of Milon Anderson and others, to see if the Town will vote to erect and maintain street lights on Vine and Kirk Streets.
- Article 27 By request of Walter W. Coe and others to see if the Town will vote to lay a sewer in Carleton Street from Brown to Centre Street and make an appropriation for the same.
- Article 28 By request of George M. Phippen and others, to see what action the Town will take with reference to adjusting the salaries of Town officials to correspond with the shrinkage of values and reduction of wages of the last thirty years.
- Article 29 By request of George M. Phippen to see if the Town will vote to number the houses and make an appropriation for the same.

- Article 30 To see if the Town will vote to authorize the Selectmen to sell the pest house lot.
- Article 31 By request of John H. George to see if the Town will vote to lay over the culvert, near the house of John H. George, as recommended by the Street Commissioners of 1894, and appropriate seventy five dollars for the same.
- Article 32 By request of John H. George, to see if the Town will vote to accept a street as laid out by the Selectmen beginning at the termination of Summer Street as accepted by the Town and running westerly by land of Arthur Young about three hundred and seventy five feet and appropriate fifty dollars for repairing the same.
- Article 33 By request of Joseph Mack and others, to see if the Town will vote to lay a sewer in French Street from Chase to Spiggot Street about two hundred feet and appropriate three hundred dollars for the same.
- Article 34 By request of the School Committee to see if the Town will vote to purchase a piece of land erect a high school building thereon, furnish and complete said building and make alterations and repairs in the old school building as required for school purposes at an expense not to exceed all told thirty thousand dollars and appropriate and borrow money therefor.
- Article 35 To see what disposition the Town will vote to make of the amount received as premium and accrued interest on the sale of bonds.
- Article 36 By request of Lewis E. Barnes and others, to see if the Town will vote to lay a sewer in Railroad Street from a point near the residence of Alonzo Howe, about five hundred feet to a point near Cemetery Street, and from thence under the Rail Road to the Spicket River about five hundred feet and appropriate one thousand dollars for the same.
- Article 37 By request of James M. Moreland and 41 others to see if the Town will vote to pay the Superintendent of Streets a salary not to exceed one thousand dollars per annum including team, the Town to have the entire services of said Superintendent.
- Article 38 By request of Silas L. Holman to see if the Town will vote to accept a street as laid out by the Selectmen, commencing at a point on Arnold Street about two hundred feet from Lowell Street and running southerly three hundred feet.
- Article 39 By request of Fred E. Lorenz and others, to see if the Town will vote to accept Boston Street from Prospect to Kendall Street, Vermont Street,

from Swan to Lawrence line, and Boylston Street from Vermont Street to Kendall Street as laid out by the Selectmen, as shown on Plan of J. M. Currier and appropriate three hundred dollars for the same.

- Article 40 By request of James O. Parker and others, to see if the Town will vote to accept Riverdale Street and Ayer Street as laid out by the Selectmen, as shown on plan recorded with North District Essex Registry of Deeds, called Fairview.
- Article 41 By request of Guy W. Currier and others, to others, to see if the Town will vote to accept Bates Street from East Street to Eustis Street, and Eustis Street from the westerly line of Bates Street, to Oak Street as laid out by the Selectmen, and as shown on plan of land called the Oaklands, owned by Guy w. Currier.
- Article 42 By request of Leverett Swan to see if the Town will vote to change the name of Plum Street to that of Tyler Street.
- Article 43 To see if the Town will vote to adopt the following By-Law. No person shall behave himself in an idle and disorderly manner nor use vulgar and indecent language, nor play at ball, nor throw or propel in any other manner, stones or other missiles in any of the public streets. Any person offending against any provisions of t his law shall forfeit and pay for each offence a fine not less than one dollar nor more than two.
- Article 44 to see if the Town will vote to accept and adopt a system sewerage for a part of said Town in accordance with Section 7 Chapter 50 of the Public Statutes; a sewer through private and public lands, running parallel with Centre Street, from a point on Merrill Street to connect with the Hampshire Street sewer in the City of Lawrence, known as Merrill Street sewer together with its proposed branches as shown on a plan on file with the Town Clerk and provide that assessments under Section 4 of Chapter 50 of the Public Statues may be made upon owners of estates within such territory.

And you are hereby directed to serve this warrant by posting up attested copies thereof at the Town House and at each of the public meeting houses in said Town, eight days at least before said meeting.

Hereof fail not, and make due return of this warrant with your doings thereon, to the Town Clerk at the time and place of meeting aforesaid.

Given under our hands and the seal of the Town of Methuen, this first day of February, in the year of our Lord one thousand eight hundred and ninety six.

John F. Ridley and Joseph J. Sharkey were appointed to act as ballot clerks, and Christopher H. Rogers and Charles E. Russell checked the list at the ballot box.

The ballots were delivered to the ballot clerks, the ballot box was opened and shown to be empty, and the key delivered to Amos G. Jones, Constable in attendance. The number on the ballot at eight o'clock and thirty five minutes and continued without interruption until eleven o'clock and thirty minutes at which time the ballot box was opened and the ballots taken therefrom by the Moderator and Town Clerk. The ballot box register marked 513 and the number of ballots taken from the box was five hundred and thirteen. The ballots were counted audibly by the Moderator, separated into blocks of fifty each, and placed in envelopes. The polls were closed at seven minutes past one. The ballot box register marked 775. The number of names checked on each voting list was seven hundred and seventy five and the whole number of ballots cast was seven hundred and seventy five. The tellers were divided into three groups, and proceeded to canvass and count the ballots while the business articles in the warrant were being acted on. All the ballots were counted into blocks of fifty each, verified and placed in envelopes, and the votes were counted recorded, and declaration thereof made and were as follows: -

Art. 4 **Appropriations**

The estimates of the Selectmen were taken up each item by itself. When the estimate for repairs on highways and bridges was reached, Mr. Mann moved that one half be expended in stone roads and the motion was lost.

When the estimate for Macadamizing was reached, it was voted to lay Article 4 on the table. It was then voted to consider Articles 13, 16 & 19 of the warrants. After considerable discussion, Articles 13, 16 & 19 were laid on the table. It was then voted that the sum of eight thousand dollars be appropriated for Macadamizing and that Centre Street, Chase Street, and a portion of laid out on Lawrence Street.

Art. 5 **Collection of Taxes**

Voted – that the taxes be collected the same as last year, and that on all taxes remaining unpaid after October first, interest shall be paid from that date to the time of payment, at the rate of six per cent per annum.

Art. 6 **Temporary Loans**

Voted – by a unanimous vote, that for the purpose of procuring a temporary loan to and
 For the use of the Town of Methuen in anticipation of the taxes of the present municipal year, the Town Treasurer is hereby authorized and directed to borrow from time to time, with the approval of the Board of Selectmen a sum or sums in the aggregate amounting to fifty thousand dollars and to execute and deliver the note or notes of the Town therefore

payable within one year from the time the loan is made, with interest thereon at a rate not exceeding five per cent per annum. Any debt or debts incurred by a loan or loans to the Town under this vote shall be paid from the taxes of the present municipal year.

to investigate and report on the cost of Electric Light Plant in the Town of
Methuen, read
the report of the Committee as follows: -

Report of Committee on Electric Light Plant

Methuen,

March 2nd 1896

Your Committee appointed at our last Annual Meeting have attended to their duties and beg leave to submit the following report. In making this report we have obtained estimates from reliable parties, and we believe that should the Town see fit to put in a plant such as our report covers, that our estimates will be found ample for the purpose. We have found it inexpedient to locate such a plant at the Pumping Station. We find that the buildings and boilers are not suitable or of sufficient capacity for the plant; also the cost of drawing coal would soon pay for a building of moderate cost. We have looked at the Pest House lot and if no better location presents itself it might be utilized. The lot measures about 80x130 feet, and is quite near the railroad. Your Committee would recommend that whether the Town should decide to put in a plant or not, that it would be good policy to retain possession of it, as property in that location is advancing. We now submit the following estimate.

The engine and boiler capacity is sufficient to run 125 Arc Lights of 2000 Candlepower, and a 1000 light incandescent machine, and at an additional expense of \$3000.00 the incandescent plant could be put in. This plant would probably be more than self-supporting.

Report of Committee on Repairs of Lowell Road

Methuen,

March 2, 1896

The Committee appointed at a Town meeting holden in 1895, to inquire into the best method to repair the Lowell road “so called” respectfully report as follows: -

Your committee has carefully examined the road and the available material for repairing the same and are of the unanimous opinion that it should be Macadamized from the Lawrence line to the point where the electric road enters the “Private land”.

Beyond said point to Dracut line it may be repaired with gravel. This would make about 2 ³/₄ miles to Macadam and about one mile to repair otherwise.

And your Committee would recommend that the Board of Selectmen for the year ensuing be instructed to obtain by purchase or otherwise sufficient material to repair said road.

Voted – To employ one efficient night watchman who shall make his headquarters at the Police Station, and perform such patrol duties as in the judgment of the Selectmen may be expedient, and that the sum of six hundred dollars be appropriated for that purpose.

Art. 13 **Chase Street**

Voted – To pass over Article 13 of the Warrant.

Art. 14 **Edge stone**

Voted – To purchase about 370 feet of edge stone to be used on Park and Lawrence Streets near the Baptist Church and appropriate one hundred and ninety dollars, for the same; also that this sum be taken from the regular appropriation, and expended as soon as practicable.

Art. 15 **Sidewalk Mystic Street**

Voted – to build a sidewalk on the left hand side of Mystic Street, from the residence of Mrs. Connor to the driveway of Mr. Webb and appropriate one hundred and fifty dollars for the same.

Art. 16 **Centre Street**

Voted – To pass over Article 16 of the Warrant.

Art. 17 **Cross Street**

A motion was made to pass over Article 17 and it was decided in the negative. It was then voted to expend three hundred and fifty dollars in repairs on Cross Street, from Pelham Street to the Pumping Station, and that this amount be taken from the regular appropriation.

Art. 18 **Water**

Voted – To pass over Article 18 of the Warrant.

Art. 19 **Prospect Street**

Voted – To Macadamize a portion of Prospect Street, beginning near the house of Mary Mitchell, and appropriate five hundred dollars for the same, and to use the stone already crushed at the ledge near Howe Street.

Art. 20 **Ashes & Garbage**

Voted – to instruct the Street Commissioner to remove ashes and garbage from private dwellings in the Town, and appropriate two hundred and fifty dollars for the same.

Art. 34 **High School House**

Voted to consider Article 34 of the Warrant.

The following resolution, offered by Mr. Hartshorne was unanimously adopted.

Resolved: 1st That it is the judgment of this meeting that the erection and equipment of a new High School building with contingent alterations in the old building is the best solution for the problem presented in the report of the School Committee.

2nd That it is the judgment of this meeting that the total cost to the Town for the site, new building and alterations in old building should not exceed thirty thousand \$30,000.00 dollars, for all present requirements.

3rd That in view of the importance of the undertaking, and the necessity for exact information, and careful consideration of the details involved, that three competent citizens be appointed to act with the members of the School Committee as a committee to consider a choice of sites, to develop plans and to procure careful estimates of all costs.

4th That this Committee be required to report its findings and recommendations as soon as practicable to a future Town meeting.

Voted – that the Committee provided in this resolution be appointed by the Moderator and the Chair appointed Lewis E. Barnes, Joseph S. Howe and J. Milton Tenney.

Art. 43

By-Law

Voted – To consider Article 43 of the Warrant.

Voted – To adopt the following By-Law.

“No person shall behave himself in an idle and disorderly manner, nor use vulgar and indecent language, nor play at ball nor throw or propel in any other manner, stones or other missiles in any of the public streets. Any person offending against any provisions of this by-law shall forfeit and pay for each offense a fine of not less than one dollar nor more than ten dollars.

Mr. Mann offered the following Resolution.

Resolved: - That the Selectmen be and are hereby instructed to take such action as shall be necessary to petition the State Highway Commission to lay out and build as State highways, Lowell Street from the Lawrence line to Dracut line, and Merrimack Street from Lawrence line to Haverhill line. And the resolution was adopted.

At about half past five, the further consideration of the business articles in the warrant was suspended, and it was voted that when the Town Meeting adjourns, it adjourn to meet at the Town Hall on Saturday next, March seventh at one o'clock p.m.

The counting of votes past for Town officers was completed and tabulation thereof made, and the vote declared about half past six o'clock.

The ballots cast for Town officers were sealed up and also the checklists used, and were taken in charge by the Town Clerk. The seal was taken by the Moderator and the meeting was then adjourned.

Record of Adjourned Annual Town Meeting March 7, 1896

The Inhabitants of the Town of Methuen entitled to vote in Town affairs, met according to adjournment at the Town Hall in said Town on Saturday March seventh at one o'clock p.m., the Moderator, Granville E. Foss, in the chair.

Rev. Charles H. Oliphant offered the following Resolutions.

Whereas: - In the Providence of Almighty God the people of this Commonwealth are called to mourn the death of their Governor, Frederic T. Greenhalge, be it –

Resolved: - by the Citizens of Methuen, in Town Meeting assembled, that we acknowledge with thankful hearts the personal worth and public service which have won for our late Governor the admiration and love of all parties and sects of the people. Recognizing in his distinguished career an example of what is best in private life and official service, we now share with the whole Commonwealth the unaffected sorrow of a great bereavement.

Resolved: - That our heart felt sympathies be expressed by the transmission of these resolutions to the smitten household with the prayer that the loving kindness and tender mercies of God may comfort and sustain them through life.

These resolutions were unanimously adopted by a rising vote.

Mr. Isaac H. Laney moved the adoption of the following.

Resolution.

Resolved: - That the Selectmen be a Committee to see the Lawrence authorities and see if they can arrange for the repair of Lawrence Street at the same time we repair Lawrence Street.

This resolution was unanimously adopted.

The meeting then proceeded to the consideration of the remaining Articles of the Warrant.

Art. 21 **Public Dump**

Voted – To instruct the Selectmen to prevent all persons from dumping rubbish on the highway, at the public dump, and have the Road Commissioner keep it in a clean and healthy condition.

Art. 22 **Hose**

Voted: - That four hundred dollars be appropriated for the purchase of hose to be located in the vicinity of Marton's Corner, and in the vicinity of the residence of Joseph E. Buswell.

Art. 23 **Sidewalk**

Voted – to appropriate one hundred dollars for continuation of sidewalk on Prospect Street and that this amount be paid from the regular appropriation.

Art. 24 **Electric Light**

By a vote of 62 to 31 it was voted to pass over Article 24 of the Warrant. At the end of the meeting a motion was made to reconsider and it was carried by more than a two thirds vote. It was then Voted: - to maintain an arc light on Pleasant Street near Highland Street and appropriate seventy dollars for the same.

Art. 25 **Electric Lights**

Voted: - to maintain four electric lights in Currier School District and appropriate seventy five dollars for the same.

Art. 26 **Street Lights**

Voted: - to pass over Article 26 of the Warrant.

Art. 27 **Sewer**

Voted: - To lay a sewer in Carleton Street, from Brown to Centre Street, and appropriate one thousand dollars for that purpose.

Art. 28 **Shrinkage**

Voted: - To pass over Article 28 of the Warrant.

Art. 29 **House Numbers**

Voted: - To number the houses in the thickly settled parts of the Town and appropriate One hundred dollars for that purpose; also that the work be done under the direction of The Assessors. Also voted that the Assessors be instructed to number the houses on Orchard Street, from Lawrence line to Lowell Street, in continuation of the numbers in the City of Lawrence.

Art. 30 **Pest House Lot**

Voted: To pass over Article 30 of the Warrant.

Art. 31 **Culvert**

Voted: - To lay over the culvert near the house of John H. George as recommended by the Street Commissioners of 1894 and to appropriate seventy five dollars for that purpose, to be taken from the regular appropriation.

Art. 32 **Summer Street**

Voted: - to accept a street laid out by the Selectmen, beginning at the termination of Summer Street, and running westerly to the land of Joseph D. Emerson, and appropriate fifty dollars therefor.

Art. 33 **Sewer French Street**

Voted: - to lay a sewer in French Street from Chase Street to Spiggot Street and appropriate three hundred dollars for the same.

Art. 35 **Premium Bonds**

Voted: - That the amount received as premium on the sale of bonds be appropriated and paid over to the Trustees of the Sinking Fund.

Art. 36

Sewer

Voted: - To lay a sewer in Railroad Street, from a point near the residence of Alonzo How about five hundred feet to a point near Cemetery Street, and from thence under the Railroad to Spicket River about five hundred feet and appropriate one thousand dollars for the same.

Art. 37

Salary Superintendent of Streets

Voted: - To pass over Article 37 of the Warrant: Yes 90 No 83.

Art. 38

Hawthorne Avenue [Street]

Voted: - To accept a street commencing at a point on Arnold Street, about 200 feet from Lowell Street and running southerly three hundred feet.

Art. 39

Voted: - To accept Boston Street from Prospect Street to Kendall Street; Vermont Street, from Swan Street to the Lawrence line, and Boylston Street from Vermont Street to Kendall Street as shown on Plan of J. M. Currier, and appropriate three hundred dollars for the same.

Voted: - To accept Riverdale Street and Ayer Street as shown on plan recorded with Northern Essex Registry of Deeds called Fairview.

Voted: - To pass over Article 41 of the Warrant.

Art. 44

Sewer Assessments

Voted: - To accept and adopt a system of sewerage, for a part of said Town in accordance
With Section 7 Chapter 50 of the Public Statutes, a sewer through private and public lands running parallel with Centre Street, from a point on Merrill Street to connect with the Hampshire Street sewer in the City of Lawrence known as the Merrill Street sewer, together with its proposed branches as shown on a plan on file with the Town Clerk and provide that

assessments under Section 4 of Chapter 50 of the Public Statutes may be made upon owners of estates within such territory.

Record of Annual Town Meeting, March 1st 1897

Pursuant to Warrant No. 10 File 12 the Annual Meeting of the Inhabitants of the Town of Methuen, was held at the Town Hall in said Town, on Monday, March 1st A.D. 1897.

The meeting was called to order at seven o'clock a.m. by Joseph S. Howe, Town Clerk,
who read the warrant for the meeting. The polls were then opened for the choice of Moderator,
the checklist being used.

Article 1 **Moderator**

Granville E. Foss received every vote cast for Moderator and was declared elected and was sworn.
Prayer was offered by Rev. Alfred Humphries (Primitive Church - Methuen)

Article 2 **Town Officers**

The Moderator announced the appointment of the following named persons as tellers and ballot clerks.

Ballot Clerks: John S. Tapley, Republican; James W. Gall, Republican; John J. Donahue, Democrat; Kirk W. Marsh, Democrat.

Teller – Republicans: Robert Moffat, Thomas Mack, Orrin E. Lowell, John T. Mannifield;
Democrats: John C. Ellis, John J. Sullivan, James E. Donahue, John P. Haran.

John J. Bunker had charge of the ballot box.

The above named persons were all sworn.

Board of Health

Mr. Parker moved the Town do not elect a Board of Health but that the duties of such be devolved upon the Board of Selectmen, with authority to appoint an agent to carry out the requirements of law. After considerable discussion the motion was carried by a unanimous vote. The ballots were delivered to the ballot clerks, the ballot box was opened and shown to be empty, and the key delivered to Amos G. Jones, Constable in attendance. The number on the ballot box register indicated four ciphers. The meeting proceeded to ballot at seven o'clock and fifty five minutes and continued without interruption until nine o'clock and fifty minutes, at which time the ballot box was opened and the ballots taken there from by the Moderator and Town Clerk. The ballot box register indicated 264, and the number of ballots taken from the box was two hundred and sixty four. The ballots were counted audibly by the Moderator, separated into blocks of fifty and placed in envelopes. At eleven o'clock and forty minutes the ballot box was again opened and the ballots taken there from by the Moderator and Town Clerk.

The number on the ballot box register was 594 and the total number of ballots taken out was five hundred and ninety four.

It was voted to extend the time for closing the polls, fifteen minutes and the polls were closed at fifteen minutes past one o'clock. The ballot box register marked 887. The number of names checked on each voting list was eight hundred and eighty seven and the whole number of ballots cast was eight hundred and eighty seven. The tellers were divided into three groups and proceeded to canvas and count the votes while the business articles in the warrant were being acted on. All the ballots were counted into blocks of fifty each, verified and placed in envelopes, and the votes were counted, recorded, and declaration thereof made and were as follows.

Article 3 **Selectmen's Report**

Voted – To accept the Report of the Selectmen

Article 4 **Appropriations**

It was voted to consider the estimates recommended by the Selectmen, item by item. When the estimate for Superintendent of Schools was reached, it was voted that the appropriation be increased to twelve hundred dollars and the expenditure of the money be left to the discretion of the School Committee.

It was voted to pass over the item for Macadam until the special appropriations for Macadamizing should be reached.

Voted – that edge stones be set only where owners of property will obligate themselves to build concrete sidewalks. The estimate for street lights was passed over until the special appropriations for street lights shall be considered. The estimate for police was passed over until Article 41 shall be reached. The estimate for maintenance of waterworks was passed over until after disposition of Article 49 of the Warrant. Mr. Oliphant offered a resolution “that the Board of Selectmen be instructed to expend one half the regular yearly appropriation for sidewalks, in making concrete or brick walks, as in their judgment shall seem best, beginning at the Town House and working north, south, east and west along the main highways as far as the appropriation will allow; and that such dire sidewalks as now exist elsewhere shall be kept in a safe and passable condition at as little expense as possible”. After considerable discussion a vote was taken and the resolution was lost.

Article 8 **Report of Committees**

The Committee on New High School Building presented the following report: -

Report of Committee on New High School Building

The Special Committee of three citizens, appointed to act with the members of the School Committee as a committee to consider a choice of sites, to develop plans and procure careful estimates of all costs, as in accordance with resolution adopted at the last Annual Town Meeting, beg leave to report: -

First: - That they have considered the question of a choice of sites with a good deal of care; not so much to determine sites with a good deal of care; not so much to determine precisely where they could procure the cheapest piece of land nor where they could make the finest show of a school building but more particularly with reference to the present requirements of a High School structure, to future development and opportunity for building for the grammar and lower grades and that the situation shall be such as will be most convenient to the largest majority of our citizens.

If they were seeking a low priced piece of land, they would naturally go outside the present thickly settled part of the Town, either to the north, east or west. If they were to choose the handsomest site for such a building, without regard to cost, they might well find such in some estate bordering Broadway. The unanimous conclusion of this committee however, is that the most eligible purchase, all things considered and the one which will furnish the Town with sufficient land for a long period in the future, for school building purposes of Grammar and High School grades, as well as Primary grades for the central portion of the Town, will be that portion of land lying between our present High School lot and Leafy Lane on the south and extending as far as Mr. Edward Johnson's

land, and now owned by the heirs of Frank F. Johnson, Margaret E. Johnson and Lucy A. Crosby, together with all the land on Lawrence Street between our present school lot on the east and the estate of K. C. Gleason's heirs on the west, and the Johnson estates on the south. The lay of these lands is shown on plan submitted herewith. Upon these estates this committee has obtained options. The total area covered, including Leafy Lane, for which title will also be given, but which cannot be entirely closed up, is fifty thousand, three hundred square feet. The total area, including present High School lot, is sixty eight thousand square feet.

There are four houses and two barns now on this land. Three of which houses, with rental value of forty-four to forty-six dollars per month, might not have to be disturbed for some time, and would in this way help to pay the interest on the investment, until that portion of the land is wanted. We recommend an appropriation for this purpose under the thirty first Article of the Warrant, of fifteen thousand, eight hundred and seventy five dollars.

Second: - The committee do not deem it advisable to enter upon any further specifications of proposed plans at this time but rest their case at this point, trusting to your approval of their recommendation and with a request that the committee, as now constituted, be continued but with power to add to their number and with instructions to report again to a meeting of the Town as promptly as circumstances will admit.

Report of Committee on Proposed New Bridge

The Committee appointed at the special Town Meeting held Nov. 16, 1896, to see what arrangements could be made with the Boston & Maine Railroad Co. for the construction of a bridge over the railroad to connect Railroad Street with a new street laid out and built as a Town way running from Union Street, report as follows: -

We communicated with the General Manager of the Railroad and he made an appointment to meet your committee with their engineer at the location of the bridge asked for, measurements were taken sufficient for their engineer to make place of bridge etc., and when completed would meet your committee in Boston. We met them in Boston, were shown plan of bridge and streets connecting with it. They claimed the privilege of saying what the abutments should be, and if the Town wished, they would build the bridge at as low a contract price as they could obtain and as their part of the expense of the construction of the bridge they would give the land for the street leading to the bridge.

This was the best terms your committee could obtain from them and was considered very unsatisfactory. The above terms were on condition that the railroad should be released from maintaining the old bridge as at present. Their engineers report that it would cost for excavation masonry and an iron overhead bridge \$8600.00 wooden bridge \$300.00 less.

Voted – To take up Article 15 of the Warrant; a motion to accept being made, Mr. R. Rogers offered the following substitute which was accepted and adopted.

Voted – that the Board of Health shall prepare and enforce such rules as are necessary for the safety and health of the people, with reference to house drainage, plumbing, and their connection with sewers and cesspools. And that two hundred and fifty dollars be appropriated, in addition to the amount already appropriated, for the purpose of defraying the expenses of the health department.

Article 16 **Watering Streets**

Voted – to accept the provisions of Chapter 186 of the Acts of 1895 relating to the watering of streets in towns.

Voted – to appropriate three hundred and fifty dollars for watering the streets.

Voted – to assess the whole cost of watering upon the abutters the cost of the water to be paid by the Town.

Voted – that the question of what streets shall be watered, be referred to the Selectmen and they be instructed to water such streets as in their judgment is deemed best.

Article 20 **Rail Road Street**

Voted – To pass over Article 20 of the Warrant.

Article 21 **Prospect Street**

Voted – to indefinitely postpone Article 21 of the Warrant.

Article 30 **Superintendent of Streets**

By request, Article 30 was considered.

Voted – To hire a Superintendent of Streets and pay him a salary not to exceed twelve hundred dollars per annum, including team, the Town to have his entire services.

A motion was made that the Selectmen be requested to appoint John Q. Hill Superintendent of Streets and the motion was lost.

Article 22 **Macadamizing**

Voted – to pass over Article 22 of the Warrant.

Voted – to appropriate twelve hundred dollars to Macadamize Lawrence Street to Lawrence line, from the regular appropriation.

Voted – that the Selectmen petition the State Highway Commission to build a State Road from Lawrence line to Dracut line and that they cause a survey of the Lowell road to be made, if in their judgment it is necessary to be done.

On motion of German S. Phippen it was

Voted – that a committee of three be appointed to re-organize the lighting system of the Town and report at a future meeting and to consider the advisability of providing an electric light plant for the Town. It was afterwards voted to add three members to this committee and the Moderator appointed the following named persons as that committee. German S. Phippen, Hon. Jacob Emerson, Geo. W. Tenney, Wm. M. Rogers, Arthur Crosby and George W. Towne.

Voted – that Articles 33 to 39 inclusive be referred to that Committee with instructions to report at an adjourned meeting.

Voted – that when this meeting adjourns it adjourn to meet in four weeks from today, April 3rd at two o'clock p.m.

Voted – that the Committee advertise and give hearings to persons interested in lighting the streets.

Voted – that it is the sense of this meeting that our Legislature should give cities and towns the right to own and operate streetcars.

Article 24 **Macadam for Sidewalks**

Voted – to supply Edward F. Searles, free of expense, crushed stone to build a sidewalk on the north side of Lawrence Street from the corner of Park Street to his residence on East Street he to do all the work without any expense to the Town. Also,

Voted – that the same privilege be granted to any citizen of the Town who will build a public sidewalk satisfactory to the Superintendent of Street.

Article 25 **Lowell Street**

Voted to pass over Article 25 of the Warrant.

Article 26 **Milk Street**

Voted – to buy about four hundred feet of land at the southeast corner of Milk Street and Baremeadow road for the purpose of taking off the sharp corner, and appropriate fifty dollars for that purpose.

Article 27 **Sidewalk**

Voted – to grade the street and build a sidewalk on Lowell Street from Arnold Street to the house of Mrs. Parker Morse, and appropriate three hundred dollars for that purpose.

Article 28 **Bates Street & Eustis Street**

Voted – to accept Bates Street from East Street to Eustis Street and Eustis from the westerly line of Bates Street to Oak Street as laid out by the Selectmen as shown on plan of land called the Oaklands and to appropriate one hundred and fifty dollars for repairing the same.

Article 29 **New Street**
